NOTIFICATION

No. 11644–ENV-II-04/2018/F&E.— Whereas, in exercise of the powers conferred by Section 25 read with sub-section (1) and clause (v) of sub-section (2) and sub-section (3) of Section 3 and Section 23 of the Environment (Protection) Act, 1986 and in supersession of the Wetlands (Conservation and Management) Rules, 2010, except as respects things done or omitted to be done before such supersession, the Central Government have made the Wetlands (Conservation and Management) Rules, 2017 in the Notification of the Government of India in the Ministry of Environment, Forest & Climate Change No. G.S.R 1203 (E), dated the 26th September, 2017;

And, whereas, the Central Government have constituted the State Wetlands Authority in each State under Sub-Rule (1) of Rule 5 of the said rules and have delegated the powers to the State Government to nominate one expert each in the fields of wetland ecology, hydrology, fisheries, landscape planning and socio-economic for the said Authority;

Now, therefore, in pursuance of clause (xvii) of sub-rule (1) of rule 5 of the Wetlands (Conservation and Management) Rules, 2017, the State Government do hereby nominate one expert each in the fields of wetland ecology, hydrology, fisheries, landscape planning and socio-economics in the following manner, namely :—
