### NOTIFICATION

No. 100/CS-OD/4 /2019(1): - **WHEREAS**, the seat of Achyutananda Samanta in the Council of States, elected by the elected members of the Legislative Assembly of the State of Odisha, has become vacant on 24.05.2019 by the reason of his election to the House of People, before the expiration of his term of office which was up to and including 03.04.2024; and

**WHEREAS**, a bye-election is to be held for the purpose of filling the vacancy so caused;

**NOW, THEREFORE**, in pursuance of section 147, sub-section (1) of section 39 and section 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby -

**(A) calls upon** the elected members of the Legislative Assembly of the State of Odisha to elect, before 09<sup>th</sup> July, 2019, and in accordance with the provisions of the said Act and of the rules and orders made there under, a person for the purpose of filling the said vacancy in the Council of States;

- (B) appoints**, with respect to the said election;
- a) the 25<sup>th</sup> June, 2019 (Tuesday), as the last date for making nominations;
  - b) the 26<sup>th</sup> June, 2019 (Wednesday), as the date for the scrutiny of nominations;
  - c) the 28<sup>th</sup> June, 2019 (Friday), as the last date for the withdrawal of candidatures;
  - d) the 05<sup>th</sup> July, 2019 (Friday), as the date on which a poll shall, if necessary, be taken; and
  - e) the 09<sup>th</sup> July, 2019 (Tuesday), as the date before which the election shall be completed; and
- (C) fixes the hours** from **9.00 a.m.** to **4.00 p.m.**, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
