No.21480-FIN-OTAS-CADRE-06/2019/F.-- In pursuance of sub-rule (a) of rule 4 read with sub-rule (1) of rule 14 of the Odisha Taxation & Accounts Services Rules, 2011 and General Administration & Public Grievance Department Letter No. 15591/Gen., dated the 4th June, 2019, the State Government do hereby appoint the following candidates who have come out successful in the Odisha Civil Services Examination, 2017 conducted by Odisha Public Service Commission, Cuttack to Odisha Taxation & Accounts Services Class-II in Pay Band-2, in the Scale of Pay of Rs.9,300-34,800/- with Grade Pay of Rs.4,600/- (Rs.44,900/- (L-10,C-1) as per O.R.S.P.
