No.9581-WCD-CW-SCHM-0040/2015/WCD&MS.— In pursuance of sub-sections (1) and (2) of Section 4 of the Juvenile Justice (Care and Protection of Children) Act, 2015, read with rule 3 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016, the Juvenile Justice Boards in the 13 Districts viz. Angul, Balasore, Bolangir, Bargarh, Deogarh, Gajapati, Ganjam, Kendrapara, Khurda, Nuapada, Puri, and Sambalpur Districts with effect from 12th June, 2019 and for Koraput District with effect from 19th June, 2019 are hereby reconstituted as follows for a period of three months or till constitution of the new Juvenile Justice Boards, whichever is earlier.
