### NOTIFICATION

**No.464/ECI/LETT/TERR/ES-II/OR-LA/2019- WHEREAS**, the Governor of the State of Odisha has, by a notification issued under sub-section(2) of Section 15 of the Representation of the People Act, 1951 (43 to 1951), published in the official Gazette of the State on the **28<sup>th</sup> March, 2019**, been pleased to call upon each of the Assembly Constituencies in the state of Odisha, as specified in column(1) of the table below to elect members to the Legislative Assembly of the State, in accordance with the provisions of the said Act and of the rules and orders made thereunder;

**NOW, THEREFORE**, in pursuance of Sections 30 and 56 of the said Act, the Election Commission of India hereby-

(A) **appoints**, with respect to the said election in each of the Assembly Constituencies specified in the said Table:-
