### OFFICE ORDER

No. 5958-14V(CASE)-17/2019/FARD.— On the recommendation of Odisha Public Service Commission, Cuttack vide their Notice No.5278/PSC., dated the 19th November, 2015 and in compliance with the order, dated the 12th September,2018 passed by Hon'ble OAT, Cuttack Bench, Cuttack in O.A. No.194(C)/2016 filed by Amit Kumar Acharya-Vrs-State and batch of cases and pursuant to opinion of Law Department vide their Endorsement, dated the 18th February, 2019 and G.A.&P.G. Department vide their endorsement, dated the 14th March, 2019, out of the 7 (Seven) candidates, who have been appointed as Veterinary Assistant Surgeon (VAS)/Additional Veterinary Assistant Surgeon (AVAS) in Odisha Veterinary Service (Group-B) vide F&ARD Department Notification No.4870/FARD., dated the 17th April, 2019, the following 5 (Five) candidates, who attended the counselling session and exercised their choice of place for posting on the date of counselling on 25th April, 2019 as per the guidelines contained in the G.A. Department Resolution No.14327/Gen., dated the 4th July, 2017, are hereby posted to the places as mentioned against the name of each candidate.

They shall remain on probation for a period of 02 (two) years from the date of joining in the post. The appointee should join at their place of posting within 30 days with effect from the date of issue of this order, failing which, his/her appointment shall be automatically cancelled. They shall abide by the other terms and conditions as laid down in the Appointment Order issued vide Government Notification No.4870/FARD., dated the 17th April, 2019.

After joining in the post of VAS/AVAS, the inter-se position shall be suitably fixed at the appropriate place in the Gradation List of O.V.S. (Group-B) Officers as per their merit position in the select list of OPSC of the year 2015 in compliance with aforesaid orders of Hon'ble Tribunal.
