No. 2809—Ele.(ML)-19/2004-SEC.—Whereas preparation of electoral roll in respect of Ward Nos. 7 and 30 of Rourkela Municipality was postponed vide Commission's Order No. 921, dated the 22nd March 2003 following interim stay granted by Hon'ble High Court in WP(C) Nos. 6153 of 2002 and 5959 of 2002;

And whereas, State Election Commission have ordered for preparation of electoral roll for these two Wards vide Order No. 282, dated the 24th January 2004 and these have been completed since February 2004;
