“Whether the action of the Management of M/s. I.T.W., Signode (India) Ltd, Rourkela employing new labourers from the outside and not reinstating the retrenched workman Shri A.K. Samal, K.C. Behera, K.K. Boity and 3 others in service is legal and/or justified ? If not, to what relief they are entitled ?”

2. Today, both parties are absent and they have taken no steps on calls. Previously also both parties remained absent on several occasions. So it seems that there is no dispute between them or have amicably settled the case in the mean time. Accordingly no dispute award is passed.
