AWARD

The Government of Orissa in the Labour & Employment Department vide Memo. No.17304 (5)-L. E., dated the 2nd December 1995 in exercise of powers conferred by sub-section (5) of Section 12, read with clause (c) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 have referred the matter in dispute to this Court vide Labour & Employment Department Notification No. 8007-L. E., dated the 18th July 1985, read with Notification No. 7550-L. E., dated the 27th June 1995 for adjudication.

“ Whether the action of the management of Dhenkanal Municipality, Dhenkanal in terminating the services of Shri Madhusudan Sahu, Shri Ulash Ch. Baral, Shri Prafulla Kumar Tripathy, Shri Bisak Behera, Shri Navin Dehury, Shri Udhav Naik with effect from the 1st June 1994 of Shri Indramani Behera with effect from the 8th July 1994 and of Shri Kamal Lochan Sahu with effect from 18th July 1994 is legal and/or justified ? If not, what relief they are entitled to ?”

2. The workmen are absent on repeated calls. No steps taken on their behalf. Similarly the management is also absent and no steps taken on its behalf. The perusal of the case record clearly emerges that both the management and the workmen are absent. In such view of the matter, a no dispute Award is passed accordingly.
