AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12, read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their order No. 17691—li-1(B)-64/2000-L.E., dated the 24th December 2001.

“ Whether the termination of services of Shri Ramesh Chandra Nayak, Office Attendant by way of the verbal refusal of employment with effect from the 22nd September 1998 by the management of Centre for Youth and Social Development (C. Y. S. D.), Bhubaneswar is legal and/or justified ? If not, what benefits the workman is entitled to ?”

2. The workman is absent on repeated calls. No steps taken on his behalf. Similarly the management is also absent and no steps taken on its behalf. The perusal of the case record clearly emerges that both the management and the workman are absent. In such view of the matter, a no dispute award is passed accordingly.
