AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12 read with clause (c) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their order No.14377—li/1 (B)-207/1994-L.E., dated the 7th November 1994.

“Whether the action of the management of M/s Sethi Transport, Madhupatna, Cuttack in terminating Shri Narayan Chandra Das, Supervisor from service with effect from the 7th February 1992 is legal and/or justified ? If not, to what relief Shri Das is entitled ?”

2. The workman is absent on repeated calls. No steps taken on his behalf. Similarly the management is also absent and no steps taken on its behalf. The perusal of the case record clearly emerges that both the management and the workman are absent repeatedly. In such view of the matter a ‘No Dispute Award’ is passed accordingly.
