NOTIFICATION

The 29th March, 2005.

S.R.O. No. 196/05— Whereas the draft of certain rules, further to amend the Inter-State Migrant Workmen (Regulation of Employment and Condition of Service) Orissa, Rules, 1980 was published as required by sub-section (1) of section 35 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (30 of 1979) in an extraordinary issue of the Orissa Gazette No.1548, dated the 17th November, 2004, under the notification of the Government of Orissa in the Labour and Employment Department No.10105-LL-I –119/2004/LE, dated the 9th November, 2004 inviting objections and suggestions from all persons likely to be affected thereby, till the expiry of a period of fifteen days from the date of publication of the said notification in the Orissa Gazette ;

And whereas, no objection or suggestion has been received during the stipulated period by the State Government in respect of the said draft;

Now, therefore, in exercise of the powers conferred by section 35 of the said Act, the State Government do hereby make the following rules further to amend the Inter-State Migrant Workmen (Regulation of Employees and Conditions of Service) Orissa Rules, 1980, namely :-

1. (1) These Rules may be called the Inter State Migrant Workmen (Regulation of Employment and Conditions of Service) Orissa Amendment Rules, 2005.

(2) They shall come into force on the date of their publication in the Orissa Gazette.

2. In the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Orissa Rules, 1980 (hereinafter referred to as the said rules for) rule 13, the following rule shall be substituted, namely :-

13. Fees – (1) The fees to be paid for the grant of certificate of registration of an establishment under section 4 shall be as specified below :-

If the number of migrant workmen proposed to be employed in the establishment on any day –

(a)	is 5, but does not exceed 20	Rs. 400.00
(b)	exceeds 20, but does not exceed 50	Rs. 1,000.00
(c)	exceeds 50, but does not exceed 100	Rs. 2,000.00
(d)	exceeds 100, but does not exceed 200	Rs. 4,000.00
(e)	exceeds 200, but does not exceed 400	Rs. 8,000.00
(f)	exceeds 400, but does not exceed 800	Rs. 12,000.00
(g)	exceeds 800, but does not exceed 1000	Rs. 13,000.00
(h)	exceeds 1000	Rs. 20,000.00

- (2) The fees to be paid for the grant of licence under section 8 shall be as specified below :-

If the number of migrant workmen recruited or employed by the contractor on any day –

(a)	is 5, but does not exceed 20	Rs. 200.00
(b)	exceeds 20, but does not exceed 50	Rs. 400.00
(c)	exceeds 50, but does not exceed 100	Rs. 800.00
(d)	exceeds 100, but does not exceed 200	Rs. 1,600.00
(e)	exceeds 200, but does not exceed 400	Rs. 3,200.00
(f)	exceeds 400, but does not exceed 750	Rs. 4,000.00
(g)	exceeds 750, but does not exceed 1000	Rs. 5,000.00
(h)	exceeds 1,000 but does not exceed 2,000	Rs. 6,800.00
(i)	Exceeds 2,000	Rs. 10,000.00

3. In the said rules, in rule 16, for the words “thirty rupees”, the words “sixty rupees” shall be substituted.
4. In the said rules, in sub-rule (2) of rule 18, for the words “seventy five rupees”, the words “one hundred and fifty rupees” shall be substituted.
5. In the said rules, in rule 19, for the words “rupees fifteen, the words “rupees thirty” shall be substituted.
