This is a reference made by the Government of Orissa, Labour & Employment Department under Sections 10 and 12 of the Industrial Disputes Act, 1947 vide memo No. 10745 (5), dated the 10th November 2003, for adjudication as to whether the termination of services of Smt. Karanjabati Sa, Peon by the management of Govindpur S. C. S., with effect from the 9th April 1998 is legal and/or justified ? If not, what relief the workman is entitled to ?
