This is the reference made by the Government of Orissa, Labour & Employment Department under sections 10 and 12 of the Industrial Disputes Act, 1947 vide memo. No. 8127(6), dated 21-08-2003 for adjudication as to “whether the termination of services of Shri Norottam Sahoo, D.G.Operator by way of refusal of employment with effect from 1-4-2001 by M/s. N. N. Pati, Contractor of M/s. N.T.P.C./T.T.P.S., Kaniha is legal and/or justified ? If not what relief he is entitled to?”

The second party workman neither filed his statement of claim nor took any step in the Court as per order of the State Government, Labour & Employment Department contained in the reference and also on issue of repeated notices from the Court.
