AWARD

The Government of Orissa in the Labour & Employment Department in exercise of their power conferred upon them by sub-section (5) of section 12 read with clause (d) of sub-section (1) of section 10 of the Industrial Disputes Act, have referred the following dispute vide Order No.3768-li/1(SS)-87/2001/LE., dated the 16th March 2005 for adjudication :

“ Whether the termination of services of Shri Sundarmani Bhumiji and 80 other workmen with effect from 1st July 2001 by the Managing Director, M/s. Lotus Chemicals Ltd., Kalunga is legal and/or justified ? If not, to what relief they are entitled ?”.

2. The case is posted today for hearing. But today neither the Union is present nor taken any steps. The representative of the management is present but he does not want to conduct the case in absence of Union. From this it can be inferred that at present the Union has no dispute with the management or that the same has been settled amicably between the parties. Accordingly no Dispute Award is passed.
