AWARD

The Government of Orissa in the Labour & Employment Department in exercise of power conferred upon them by sub-section (5) of section 12 read with clause (d) of sub-section (1) of section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No.5196-Ii/1-478/89/LE., Dated the 11th April 1991.

“Whether the action of the Management of M/s. Panthanivas, Bhubaneswar in terminating the employment of Shri Bijaya Kumar Mohanty w.e.f. 25th November 1988 is legal and/or justified ? If not, to what relief is the workman entitled ?”

2. The concerned workman is absent on repeated calls. No steps taken on his behalf. The case is posted today for hearing. No prayer is made by the either the parties to adjourn the case to some other date for hearing. On perusal of the case record, it is seen that, the concerned workman is absent today and took no steps. Since the workman is absent today, no Award is possible.
