ORDER

The 10th June 2005

No. 2062-SEC.—Whereas Sub-Collectors of different districts have submitted proposal of by-election to the office of the Sarpanches as per the Orissa Grama Panchayat Election Rules, 1965;

Whereas Commission has decided to revise Electoral Roll for the concerned Grama Panchayat on the basis of Assembly Electoral Roll published by the Election Commission of India during January, 2005;

And whereas, it is necessary to prepare wardwise Electoral Rolls of Grama Panchayats as per the following statement for conduct of by-elections.

Now, therefore, the State Election Commission in exercise of powers vested in it by virtue of Article 243 K of the Constitution of India, read with Section 9 (2) of the Orissa Grama Panchayat Act, 1964 and Rules framed thereunder directs that wardwise preliminary Electoral Roll of concerned Grama Panchayat shall be prepared in the Form No. 1 prescribed by the Commission according to the procedure prescribed in the Annexure I of this Order as per the Schedule detailed in Annexure II.

ANNEXURE I

The Collector as Electoral Registration Officer will be in overall charge of preparation and finalisation of electoral roll of the concerned Grama Panchayats.

2. Ordinarily the Collector shall authorize the B. D. O. to function as E. R. O. in respect of their Grama Panchayats. He may also authorize concerned Sub-Collector & Tahasildar as a stand by measure.

3. The electoral roll of Assembly Constituency prepared and published last by the Election Commission of India during January, 2005 and currently in force shall be the basis of preparation of the preliminary wardwise electoral roll. For the purpose, the electoral roll of Assembly Constituency relating to the Grama Panchayat as per the statement only have to be Xeroxed and split into separate electoral rolls for every Ward as per Rule 5 (1) of the O. G. P. E. Rules. The preliminary electoral roll shall be prepared in Form No. 1 prescribed by the Commission under the seal and signature of the Electoral Registration Officer.

4. The preliminary electoral roll of the Ward prepared in accordance with Rule 5 (1) of O. G. P. E. Rules shall be published by the E. R. O. at a conspicuous place at the headquarters of the Grama Sasan together with a notice in Form No. 2 in accordance with the provisions under Rule 5 (1). Such notice together with copy of preliminary electoral roll shall also be published in the noticeboard of the concerned Panchayat Samiti, Sub-Collectors & Collector. It should be ensured that copies of preliminary electoral roll is kept open at G. P. Office for inspection by the public for entire period prescribed during filing of objections or claims.

5. The Electoral Registration Officers shall dispose the claims and objections as per the instructions communicated in letter No. 1528/SEC., dated the 22nd April 2005 within the Scheduled dates.

6. After completion of enquiry into all claims & objections in the manner prescribed under Rule, the E. R. O. shall prepare & publish the final Electoral Roll.
