ORDER

The 19th August 2005

No. 2778-SEC.—Whereas it is reported by the Executive Officer, Rayagada Municipality that causal vacancy in the office of Vice-Chairperson has occurred due to death of Councillor of Ward No. 13 who was holding the post of Vice-Chairperson on the 27th June 2005 ;

And whereas, it is necessary to fill up the said causal vacancy.
