AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12, read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 2413—li/1(BH)-69/1998-LE., dated the 19th February 1999 :—

“Whether the action of the management of M/s. IPITATA Refractories Limited, Dhenkanal in dismissing the services of Shri Jambeswar Bhoi, Helper with effect from the 24th February 1997 as contained in the letter No. IPL/P.D./797/1997, dated the 24th February 1997 is legal and/or justified ? If not, to what relief Shri Bhoi is entitled to ?”

2. The concerned workman is absent on repeated calls. No steps taken on his behalf. The case is posted today for hearing. No prayer is also made by the either party to adjourn the case to some other date for hearing. On perusal of the case record, it is seen that, the workman has been remained absent since the 3rd March 2003. Since the workman concerned is absent today a No dispute Award possible is passed accordingly.
