AWARD

This case arises out of the reference made by the Government of Orissa, Labour & Employment Department under Sections 10 & 12 of the Industrial Disputes Act, 1947 for vide Memo No. 14456(5)-L.E., dated the 27th November 2000 for adjudication of disputes Schedule below :

“Whether the termination of services of Shri Mihir Kumar Dhal, Ex-Junior A.F.S.-*cum*-Clerk by the management of Orient Paper Mills Forest Organisation, Sambalpur with effect from the 9th April 1999 is legal and/or justified ? If not, to what relief Shri Dhal is entitled ?”.

After filing of statement of claim and written statement by the workman and management respectively, both parties did not appear in the Court subsequently nor taken any step in spite of repeated notices to them. As it appears, they are not interested to proceed with the present case. Hence, I do hereby pass a ‘No Dispute Award’, so far as the dispute under the present reference is concerned.
