This case arises out of a reference made by the Government of Orissa, Labour & Employment Department under Sections 10 & 12 of the Industrial Disputes Act, 1947 for vide Memo. No. 12049(5)-L.E., dated the 16th December 2003 for adjudication of disputes Schedule below :

“Whether the termination of services of Shri Kishore Ch. Jena by way of refusal of employment with effect from the 3rd July 2000 by the Range Officer (Territorial) Pallahara, Dist. Angul is legal and/or justified ? If not, what relief is Shri Jena entitled to ?”.

After filing of statement of claim and written statement by the workman and management respectively, both parties did not appear in the Court subsequently nor taken any step inspite of repeated notices to them. As it appears, they are not interested to proceed with the present case. Hence, I do hereby pass a ‘No Dispute Award’, so far as the dispute under the present reference is concerned.
