This case arise out of the reference made by the Government of Orissa, Labour & Employment Department under Sections 10 & 12, of the Industrial Disputes Act, 1947 , vide Memo No. 12127(6), dated the 17th December 2003 for adjudication of disputes scheduled below :—

“Whether the action of the management of M/s. Sarabhai Piramal Pharmaceuticals Pvt. Ltd., Vadodara in dismissing Shri Arijit Ghosh, Professional Sales Representative with effect from the 28th June 2001 is legal and/or justified ? If not, what relief is he entitled to ?”

The second party nither filed his statement of claim nor took any step in the Court inspite of the Order of the State Government, Labour & Employment Department contained in the reference and also on issue of repeated notices from the Court and repeated adjournments.
