AWARD

This is a reference under Section 10(1) read with Section 12(5) of the Industrial Disputes Act, 1947 made by the State Government of Orissa in their Labour & Employment Department Memo. No. 1620 (5), dated the 13th February 2004 for adjudication of the dispute mentioned below :

SCHEDULE

“Whether the termination of services of Shri Herod Nayak, Ex-Assistant Cook by the management (Bishop) of M/s Diocess of Phulbani with effect from the 1st July 2001 is legal and/or justified ? If not, what relief is Shri Nayak entitled to ?”

2. While referring the dispute for adjudication the Government in their Memo No. 1621 (6), dated the 13th February 2004 directed the workman to file the W.S. with serving copy on the Management. Copy was also served on the management. They filed Form-K duly signed by the both parties and witness. After that, this Court directed to the both parties for filing appointment order and joining report of the workman before this Court. Both parties are complied this Court’s order and filing the same accordingly. Hence the Form-K of the both parties are accepted. This being the position there appears “No Dispute” between the parties. Hence, pass No Dispute Award. Award of No Dispute passed.
