### AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12, read with clause (c) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 6243-LE., dated the 17th July 2004 :—

“Whether the termination of service of Shri Pramod Kumar Rout, Ex-D. R. chairman, with effect from the 1st December 2001 by the Ex-Engineer, Mahanadi Chitrotpala Island Irrigation No. II, Garadpur, Dist. Kendrapara is legal and/or justified ? If not, to what benefit is Shri Rout entitled to ?”

2. The concerned workman is absent on repeated calls. No steps taken on his behalf. The management is also absent. The case is posted today for hearing. No prayer is also made by the either party to adjourn the case to some other date for hearing. On perusal of the case record, it is seen that, the workman is absent since the 20th July 2004.. Since the workman concerned is also absent today. Hence a No Award possible is passed accordingly.
