### AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12, read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 17077-LE., dated the 5th December 1996 :—

“Whether the action of the management of IPISTEEL Limited, Gundichapada, dhenkanal is striking off the name of the workman Shri Rabindra Kumar Barik from the mustor roll with effect from the 15th May 1993 is legal and/or justified ? If not, to what relief he is entitled to ?”

2. The concerned workman is absent on repeated calls. No steps taken on his behalf. The management is also absent. The case is posted today for hearing. No prayer is also made by the either party to adjourn the case to some other date for hearing. On perusal of the case record, it is seen that, the workman is absent since the 24th December 2003.. The workman concerned is also absent today. Hence a No Award possible is passed accordingly.
