AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12, read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 2548-li-I(BH)-LE., dated the 26th February 2002.

“Whether the action of the Executive Engineer, Rengali Right Canal Division No III, Banarapal, Angul in terminating Shri S. K. Padhi, DLR. Typist from service with effect from the 15th October 2000 F.N. as per his letter No. 2374, dated the 14th September 2000 is legal or justified ? If not, to what relief Shri Padhy is entitled ?”

3. The concerned workman is absent on repeated calls. No steps taken on his behalf. The Management also absent. The case is posted to today for hearing. No prayer is made by either party to adjourn the case to some other date for hearing. On perusal of the case record, it is seen that the workman is absent since the 2nd March 2002. The workman concerned is absent today. Hence, a “No Dispute Award/Possible” is passed accordingly.
