“Whether the action taken by the management of M/s Ponni Sugars and Chemical Limited, Sagarpali, P.O. Deogaon, Dist. Bolangir in dismissing Shri Kanhu Ch. Pradhan can Assistant vide Letter No. 505 of 2000, dated the 9th february 2000 is legal and/or justified ? If not, to what relief he is entitled ?”.

After filing of statement of claim and written statement by the workman and management respectively, both parties did not appear in the Court subsequently nor taken any step in spite of repeated notices to them.
