“Whether the termination of services of Shri Sricharan Biswal with effect from the 11th July 1998 by the Contractor Shri Gangadhar Rout of Orissa Synthetics Limited at present renamed as Orissa Polyfibres Limited, Baulpur, Dhenkanal is legal and/or justified ?”
