AWARD

The Government of Orissa in the Labour & Employment Department, in exercise of powers conferred upon them by sub-section (5) of Section 12, read with clause (c) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 15204-L.E., dated the 23rd December 2002 :—

“ Whether the termination of Service of Kumari Manjulata Sahoo, Pump Attendant with effect from the 5th June 2001 by the management of M/s Swarna Filling Station, Iginia, Bhubaneswar is legal and/or justified ? If not, what relief Kumari Sahoo is entitled to ?”

2. The concerned workman is absent on repeated calls. No steps taken on her behalf. The management is also absent. The case is posted to today for hearing. No prayer is also made by either party to adjourn the case to someother date for hearing. On perusal of the case record it is seen that, the workman is absent to day. Hence a no award is possible is passed accordingly.
