AWARD

The Government of Orissa in the Labour & Employment Department, in exercise of powers conferred upon them by sub-section (5) of Section 12, read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 12957—li-1(B)-90/2002-L.E., dated the 24th October 2002 :—

“ Whether the action of the Contract agency Shri Sridhar Das, Port Operation contractor of M/s Paradeep Phosphates Ltd., Paradeep, in refusing employment to shri subash Chandra Bhatta a contract worker with effect from the 1st September 2001 on account of none insurance of gate by the management of Paradeep Phosphates Ltd., Paradeep (the Principal Employer) in favour of the workman is legal and/or justified ? If not, what relief the workman is entitled to ?”

2. The concerned workman is absent on repeated calls. No steps taken on her behalf. The management are also absent. The case is posted to today for hearing. No prayer is also made by either party to adjourn the case to some other date for hearing. On perusal of the case record it is seen that, the workman is absent since the 27th May 2005. The workman concerned is also absent today. Hence a no award is possible is passed accordingly.
