### AWARD

The Government of Orissa in the Labour & Employment Department, in exercise of powers conferred upon them by sub-section (5) of Section 12, read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 14156-L.E., dated the 5th December 2002 :—

“ Whether the action of the management M/s Passari Cellulose Ltd., Balgopalpur, Balasore in declaring ‘Lock-out’ in their notice, dated the 2nd November 2001 with effect from 6 A.M. of the 2nd November 2001 is legal and/or justified ? If not, what relief are the workmen of the Industry (Annexure-A) entitled to ?”

2. The concerned workmen are absent on repeated calls. No steps taken on his behalf. The management is also absent. The case is posted today for hearing. No prayer is also made by either party to adjourn the case to some other date for hearing. On perusal of the case record, it is seen that, the workmen are absent since the 16th December 2002. The workmen concerned are also absent today. Hence, a No Award, possible is passed accordingly.
