SUBJECT— Constitution of “Fly Ash/Blast Furnace Slag (BFS) Mission”, Orissa for promotion of usages of Fly Ash/BFS in the State—Regarding.

No. 17832—ISI.-160/2006-I.—With a view to laying greater thrust in the matter of promotion of usage of Fly Ash/BFS, Government have now been pleased to constitute the “Fly Ash/BFS Mission, Orissa,” in supersession of this Department’s earlier Notification No. 10589, dated the 12th September 2005 constituting the Working Group on Fly Ash, as follows :—

1. Assessment of the current generation and utilization of Fly Ash/BFS in the State
2. Identification of suitable uses of Fly Ash/BFS
3. Recommendation of suitable policy and regulatory measures to promote the utilization of Fly Ash/BFS.
4. Sensitization of all stakeholders
5. Drawing up of action plan for speedy utilization of Fly Ash/BFS
6. Government Procurement Policy in respect of Fly Ash/BFS products
7. Fiscal incentives for manufactures of value added Fly Ash/BFS products
8. Any other related issues
