ORDER

SUBJECT— Preparation of Wardwise Electoral Roll for conduct of by-election to Ward No. 9 of Nilagiri N. A. C.

No. 4782—Ele.(ML)-48/2006-SEC.—Whereas, the Executive Officer, Nilagiri N. A. C. vide his letter No. 1017, dated the 20th November 2006 has reported that a casual vacancy in the office of Councillor of Ward No. 9 has occurred due to death of the Councillor ;

Whereas, it is necessary to prepare updated Electoral Roll for Nilagiri N. A. C. to conduct the by-election and for that Commission has decided that Assembly Electoral Roll published by ECI/CEO on the 10th March 2006 will be the basis for preparation of Wardwise Electoral Roll ;

Now, therefore, the Commission, in exercise of the powers vested in it under Article 243-ZA of the Constitution of India, read with Section 13(1) of Orissa Municipal Act, 1950 and Rule 4 of the Orissa Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 directs that Wardwise Preliminary Electoral Roll of Nilagiri N. A. C. shall be prepared as per manner prescribed in Schedule - II by the Commission according to the programme laid down in Schedule - I of this order.

SCHEDULE - II

PROCEDURE FOR PREPARATION OF THE ELECTORAL ROLL FOR NILAGIRI N. A. C.

1. The Election Officer appointed by the Commission will be in-charge of preparation and finalisation of the Electoral Rolls of the Nilagiri N. A. C.

2. The Electoral Roll of the Assembly Constituency prepared by the Election Commission of India published during March, 2006 (currently in force) shall be basis for preparation of the Preliminary Wardwise Electoral Rolls of the Nilagiri N. A. C.

3. Preliminary Electoral Roll for each Ward shall be prepared in accordance with Rule 4 and be published in accordance with Rule 7. It should be ensured that the copies of the Preliminary Electoral Roll or the portion thereof, as the case may be, relating to each Ward shall be kept open for inspection by the public for a period indicated in the programme drawn up by the Commission vide Schedule-I. An Assistant/Clerk may be entrusted to help the public in the inspection of the Preliminary Electoral Roll during the period.

4. It has been provided in Rule 7(4) that the fact of publication of Preliminary Electoral Roll shall be notified in one or more **Oriya Newspapers** circulating in the district. A Model Format in Oriya is given at Appendix 'A' of this Schedule, which may be published with necessary modification in **one Newspaper between the 16th December 2006 to the 21st December 2006.**

5. Any person whose name is already enrolled in the Assembly Electoral Roll, 2006 but does not find place in the Wardwise voter list now prepared as per Para. 3 above can file claims/objections for enrollment/correction in the entry in Form Nos. III & IV respectively. **It is made clear that fresh claim for enrollment as voter shall not be entertained.**

6. After hearing and disposal of claims and objections and finalisation of the Electoral Roll by the Election Officer under Rule 11, the final Electoral Roll shall be published for three consecutive days at the prescribed places under Rule 15. The Commission has prescribed a Model Form at Appendix 'B' of this Schedule to be used for final publication of the Electoral Roll.

7. The final Electoral Roll shall be authenticated under signature of the Election Officer concerned with date and official stamp as follows :—

“Certified that the Electoral Roll of Ward No..... Nilagiri N. A. C. has been duly prepared and the final roll duly published as per provision of Orissa Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 on.....”

8. The final Electoral Roll so published shall then be split up Polling Station/Boothwise (each booth allotted to about 1,000 voters) in accordance with Commission's direction in the matter.

9. After splitting of the final Electoral Roll boothwise, **only the Electoral Roll where by-election is going to be held shall be printed** as per requirement (ideally @ 3 copies per booth + copies to Political parties + Commission's copy + Office copy). Photostat copies of the Electoral Roll of the Wards of the N. A. C. shall be duly authenticated and forward to Commission. Each National Party/State Party shall be supplied a copy along with printed copy discussed above free of cost.
