ORDER

The 15th February 2006

No. 621—Ele.-MI.-16/2006-SEC.—Whereas, it is reported by the Executive Officer, Brajarajnagar Municipality that casual vacancy in the office of Chairperson of Brajarajnagar Municipality has occurred due to no-confidence motion passed against the Chairperson on the 10th October 2005 ;

Whereas, the Chairperson has filed a writ petition W. P. © No. 12881 of 2005 in the Hon'ble High Court wherein the Hon'ble High Court have not passed any interim stay order ;

Whereas, it is necessary to conduct by-election to fill up the vacancy ;

Now, therefore, in exercise of powers conferred under Section 49 of the Orissa Municipal Act, 1950 and Rule 68 of the Orissa Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election Rules), 1994, the State Election Commission appoints following dates for holding of election to fill up the aforesaid casual vacancy of Chairperson of Brajarajnagar Municipality. However, the result of this by-election would abide by the result of the aforesaid writ petition :—
