ORDER

The 16th March 2006

No. 1039—Ele.-MI-16/2006-SEC.—Whereas it is reported by the Executive Officer, Bhuban N.A.C. that casual vacancy in the office of Chairperson of Bhuban N.A.C. has occurred due to No Confidence Motion passed against the Chairperson on the 20th February 2006;

Whereas it is necessary to conduct by-election to fill up the vacancy.
