ORDER

The 12th May 2006

No. 1660—Ele.-G.P.-1/2006-SEC.—Where as Collector, Jajpur & Jharsuguda have reported that there was failure of election to the office of P. S. Member of Mugupal G. P. and Charpali G. P. under Rasulpur and Lakhanpur Panchayat Samiti in the district of Jajpur and Jharsuguda respectively as no nomination was filed/all nominations were rejected and the programme for revision of electoral roll have been communicated vide Commission's order No. 1254, dated the 4th April 2006.

Now, therefore, the State Election Commission in exercise of its powers conferred under Article 243-K of Constitution of India Section 45C(1) of O. P. S. Act, 1959 and such other enabling powers on that behalf has been pleased to order that fresh election shall be held in respect of the said Offices as per following schedule :—
