No. 16049—Misc.-Co.-II.-17/2005-P.—The House Committee on Ethics of the Orissa Legislative Assembly in their Report presented to the Assembly, recommended to constitute Development Committees Assembly Constituencywise in the State with a view to reviewing all the developmental works in the respective Constituencies. The above recommendation of the Committee was also adopted by the Assembly unanimously in the sitting held on the 6th April 2005.

In due deference and after careful consideration of the above decision of the Orissa Legislative Assembly, the Government have been pleased to constitute Development Committee Assembly Constituencywise as laid below :

ASSEMBLY CONSTITUENCYWISE DEVELOPMENT COMMITTEE

COMPOSITION :

1. M. L. A. of the Constituency . . . Chairman
2. Block Development Officers and Executive Officers of
N. A. C./Municipalities within the jurisdiction of the Constituency. . . Members
3. District Level Officers executing development works or their
Subdivisional Officers nominated by them. . . Members
4. Chairman of the concerned Panchayat Samities . . . Special Invitees
5. Collector or any other officer not below the rank of the A. D. M. . . Member-Convenor
appointed by the Collector.
6. Representative of the Collector not below the rank of A. D. M. . . Member
of the District/Districts to which the constituency spills over.

OBJECTIVES :

Objective of Assembly Constituencywise Development Committee is primarily to apprise the Hon'ble M. L. A. of the concerned Constituency about all the developmental and welfare schemes under execution and problems, if any.

MEETING :

The Committee shall meet once in a quarter at district Headquarters/Subdivisional Headquarters/Block Headquarters or at a suitable place to be chosen by the Committee. Collector of the district or in the absence of the Collector, an officer not below the rank of A. D. M. will attend the meeting of the Development Committee and he will also take steps to issue the minutes of the meeting. The concerned Officers/Engineers will brief the Committee regarding implementation of various programmes/Projects relating to their Departments and take action as deemed appropriate as per observation of the Committee.

FUNCTIONS :

The Committee may review all the development works of the Constituency and give its advice to the concerned authorities as deemed proper. The Committee will have no access to Government records/files whatsoever relating to any Projects/Schemes.

Notification No. 15992-P., dated the 7th November 2005 issued in this Department to this effect stands cancelled.
