AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of section 12 read with clause (d) of sub-section (1) of section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 11259/LE., dated the 25th August 1995.

“Whether the termination of services of Shri Nibaram Panda, Watchman by way of refusal of employment by the Management of M/s. Orissa Textile Mills Ltd., Choudwar, Dist. Cuttack w.e.f. the 7th November 1981 is legal and/or justified ? If not, to what relief he is entitled to ?”

2. The concerned workman is absent on repeated calls. No steps taken on his behalf. The case is posted today for *ex parte* hearing. No prayer is also made by the workman to adjourn the case to some other date for *ex parte* hearing. On perusal of the case record it is seen that, the workman has been remained absent since the 18th April 2005. Since the concerned workman is absent today no award is possible. Hence a no dispute Award is passed accordingly.
