AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of section 12 read with clause (d) of sub-section (1) of section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 10922/LE., dated the 12th August 1999.

“ Whether the termination of services with effect from 3rd August 1998 of Shri Makardhaj Bhoi, Helper and Shri Pramod Kumar Swain, Mason, contract labourers working in Building centre, Laxmi Sagar by the Executive Engineer, Division-IV, Bhubaneswar Development Authority is legal and/or justified ? If not, to what relief they are entitled ?”

2. The concerned workman is absent on repeated calls. No steps taken on his behalf. The case is posted today for *ex parte* evidence from the side of the Management. The Management is also absent today. No prayer is also made to adjourn the case to some other date for *ex parte* hearing by the Management. On perusal of the case record, it is seen that, due to absence of the workman, were set *ex parte* and absent today, no award is possible. Hence a no dispute Award is passed accordingly.
