## INDUSTRIES DEPARTMENT

### NOTIFICATION

The 7th June 2006

No. 8538—I-TTI-7/2006-I.— Consequent upon the judgement of Hon'ble Supreme Court, dated the 14th August 2003 in W. P. (c) No. 350/1993 (Islamic Academy of Education and another *Vrs.* State of Karnatak and others), Government was pleased to constitute a Committee for fair and transparent conduct of Common Entrance Test (C.E.T.) to be conducted by the Association of Private Professional Colleges vide this Department Notification No. 7868, dated the 6th May 2004 and subsequent Notifications No. 10187, dated the 16th June 2004, No. 14784, dated the 23rd August 2004 and No. 14772, dated the 23rd August 2004. Accordingly, the C.E.T. Monitoring Committee is monitoring the C.E.T. Examination conducted by Association of Private Professional/Technical Colleges for admission in to B. E./B. Tech., M.C.A., H.M.C.T., M.B.A. and B. Pharma Courses.

H. & F. W. Department vide their U.O.I. No. 9945-H. & F.W., dated the 25th May 2006 have requested this Department to constitute C.E.T. Monitoring Committee to oversee the admission into M.B.B.S./B.D.S. Courses in Private Medical/Dental Colleges for the academic session 2006-2007. As per the direction of Hon'ble Supreme Court in W. P. (c) No. 350/1993 there shall be one committee for each State to supervise both the examinations (Technical and Medical). Accordingly, the Committee constituted vide this Department Notification as mentioned above will also monitor the C.E.T. to be conducted by the Association of Private Medical and Dental Colleges for admission into M.B.B.S./B.D.S. Courses. As per the stipulation laid down in the aforesaid judgement Principal Secretary to Government, Health & Family Welfare Department will replace the Principal Secretary to Government, Industries Department as Member-Secretary and one eminent Doctor will replace Engineer as nominated Member when the Committee will meet for monitoring C.E.T. for Medical and Dental Courses. The Notification of Industries Department bearing No. 7868, dated the 6th May 2004 provides scope for this.

Government after careful consideration of the direction of Hon'ble Apex Court have been pleased to decide that the C.E.T. Monitoring Committee constituted vide this Department Notifications under reference will also monitor the C.E.T. Examination to be conducted by the

Association of Private Medical/Dental Colleges for admission into M.B.B.S./B.D.S. Courses as per the option exercised by individual Institutions for the academic session 2006-2007. For the purpose, Principal Secretary to Government, Health & Family Welfare Department and Dr. Basudev Kar will function as Member-Secretary and nominated Member of the Chairman of the C.E.T. Committee respectively for monitoring the C.E.T. to be conducted by Association of Private Medical/Dental Colleges.

The Committee will meet simultaneously as far as practicable to monitor the examinations for both Technical and Medical stream and will complete the entire process within the prescribed time period specified i.e. by the 31st August 2006. All other terms and conditions prescribed vide this Department Notification under reference and terms and conditions to this effect laid down by Finance Department will remain unchanged.
