AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of section 12 read with clause (d) of sub-section (1) of section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 9055/L.E., dated the 5th July 2000.

“ Whether the action of the Executive Engineer of erstwhile Sunei Irrigation Division, Udaya merged in Mayurbhanj Irrigation Division, Baripada in terminating the services of Shri Kasinath Nayak, NMR workman with effect from 1-2-1986 is legal and or justified ? If not, what relief he is entitled to ?”

2. The concerned workman is absent on repeated calls. No steps taken on his behalf. The case is posted today for hearing. No prayer is also made by either the party to adjourn the case to some other date for hearing. On perusal of the case record, it is seen that, the workman has been remained absent since 5-8-2002. Since the concerned workman is absent today no award is possible. Hence a no dispute Award is passed accordingly.
