ORDER

No. 4718—Ele.(ML)-53/2007-SEC. — Whereas, Executive Officer of Redhakhol N.A.C. vide his letter No. 107, dated 29-01-2007 has reported that a casual vacancy in the Office of Councillor of Ward No. 7 of Redhakhol N.A.C. has occurred due to resignation of the Councillor.
