ORDER

The 14th September 2007

SUB.—Preparation of Wardwise Electoral Roll for conduct of by-election to Ward No. 14 of Paradeep Municipality.

No. 5795—Ele-(ML) 61-07-SEC.—Whereas the Executive Officer, Paradeep Municipality vide his Letter No. 2637, dated the 28th August 2007 has reported that a casual vacancy in the office of Councillor of Ward No. 14 has occurred due to removal of the Councillor ;

Whereas, it is necessary to prepare updated Electoral Roll for Paradeep Municipality to conduct the by-election and the Commission has decided that Assembly Electoral Roll published by ECI/CEO on the 8th February 2007 will be the basis for preparation of Wardwise Electoral Roll ;

Now therefore, the Commission, in exercise of the powers vested in it under Article. 243 ZA of the Constitution of India read with Section 11 (A) of the Orissa Municipal Act, 1950 directs that Wardwise Electoral Roll of Paradeep Municipality shall be prepared as per manner prescribed in Schedule 11 by the Commission according to the programme laid down in Schedule-I of this order.
