AWARD

This case arises out of the reference made by the Government of Orissa, Labour &

Employment Department under Sections 10 and 12 of the Industrial Disputes Act, 1947 for adjudication of the disputes vide Memo No. 2429 (5)-L.E., dated the 8th March 2004 scheduled below :

“Whether the refusal of employment to all workmen of Aluminium Industries Ltd., Hirakud represented through Aluminium Industries Employees Union, Hirakud by the management of Aluminium Industries Ltd., w.e.f. the 31st May 1997 in the garb of suspension of work is legal and/ or justified ? If not, what relief the workmen are entitled to ?”

In obedience to the order of the Government, Labour & Employment Department the second party-workmen through their Union filed statement of claim after serving copy on the management on receipt of notice from the Court for filing of written statement, the first party management neither filed written statement nor took any steps. But thereafter the second party-workmen and the Management did not appear in the Court in spite of repeated notices from the Court. As it appears, the workmen are not interested to proceed with the present case. Hence, I do hereby pass a “ No Dispute Award” so far as the present reference is concerned.
