AWARD

This case arises out of the reference made by the Government of Orissa, Labour & Employment Department under Sections 10 and 12 of the Industrial Disputes Act, 1947 vide memo No. 14423 (5), dated the 8th October 2001 for adjudication of disputes scheduled below :

"Whether the action of the management of Orient Paper Mills, Brajaraj Nagar in declaring lockout of Finishing House w.e.f. 7 A.M. of 18th September 1997 and suspension of work of entire factory from 7 A.M. of 19th September 1997 till 'B' Shift of 22nd September 1997 is legal and/justified ? If not, whether the workman covered under the said notices are entitled to wages for the said period ?"

2. After filing of statement of claim and written statement by the workman and management respectively, both parties did not appear in the Court and also did not take steps, in spite of repeated notices to them. As it appears, they are not interested to proceed with the present case. Hence, I do hereby pass a 'No-Dispute Award' so far as the dispute under the present reference is concerned.
