1. This case arises out of the reference made by the Government of Orissa, Labour and Employment Department U/s. 10 & 12 of the Industrial Disputes Act, 1947 vide Memo. No. 8771(4), dated the 20th October 2005 for adjudication of disputes scheduled below:—

“whether the termination of services of Shri Prasanna Kumar Sahoo, Assistant Tax-Sarkar by way of refusal of employment with effect from 11th December 2004 by the Management of Belpahar N.A.C., Belpahar is legal and/or justified ? if not, what relief is the workman entitled to ?”

The second party workman neither filed his statement of claim nor took any step in the Court as per order of the State Government, Labour and Employment Department contained in the reference and also on issue of repeated notices from the Court.
