ORDER

The 26th June 2008

No. 2787-SEC.—Whereas the State Election Commission had directed not to publish the final Electoral Roll in respect of Balasore Municipality vide Commission's letter No. 1214, dated the 4th April 2008 in view of the clarification sought for by the Additional District Magistrate, Balasore in pursuance of the interim order, dated the 27th March 2008 of the Hon'ble High Court in W.P. (C) No. 4467/2008 (Nasir Khan and another *Vrs.* State & Others);

Whereas the Hon'ble High Court vide its order, dated the 15th May 2008 have disposed of the W.P. (C) No. 4467/2008, W.P.(C) No. 4619/2008 & W.P. (C) No. 5392/2008 with a direction to the petitioners to file an appeal before the appellate authority within a period of 10 days and the appellate authority shall dispose of the same within a period of 15 days;

Whereas the appellate authority, i.e. the Government in Housing & Urban Development Department have complied the orders of the Hon'ble High Court and duly intimated the Commission vide its Memo No. 17350, dated the 25th June 2008.

Now, therefore, in exercise of powers conferred under Article 243-ZA of the Constitution of India, read with Section 13 of the Orissa Municipal Act, 1950, the State Election Commission hereby directs that final publication of the Electoral Roll in respect of Balasore Municipality shall be done as per the following schedule :
