ORDER

The 23rd June 2008

No. 2767-SEC.—Whereas the State Election Commission had directed not to publish the final Electoral Roll in respect of Kantabanji N.A.C. vide Commission's Letter No.1333, dated the 15th April 2008 in view of the clarification sought for by the District Magistrate, Balangir in pursuance of the interim order, dated the 4th April 2008 of the Hon'ble High Court in W.P. (C) No.5084/2008 (S. Jagannath Rao and others *Vrs.* State & others) ;

Whereas the Hon'ble High Court vide its order dated the 15th May 2008 have remanded back the case to the Appellate Authority to reconsider the appeal of the petitioner within ten days after receipt of the fresh application from the petitioner ;

Whereas the Appellate Authority i.e., the Government in Housing & Urban Development Department have complied the orders of the Hon'ble High Court and duly intimated the Commission vide its Memo No. 16976, dated the 21st June 2008.

Now, therefore, in exercise of powers conferred under Article 243ZA of the Constitution of India, read with Section 13 of the Orissa Municipal Act, 1950, the State Election Commission hereby directs that final publication of the Electoral Roll in respect of Kantabanji N.A.C. shall be done as per the following Schedule:—
