## STATE ELECTION COMMISSION, ORISSA

### NOTIFICATION

The 27th August 2008

**S.R.O. No. 423/2008**—Whereas State Election Commission in Notification No. 3713, dated the 11th August 2008 has appointed dates and time for holding General Election to 92 Urban Local Bodies. The date of issue of nomination forms and presentation thereof is fixed from the 20th August 2008 to the 26th August 2008 (except public holidays);

And, whereas, this Commission in Notification No. 4701, dated the 25th August 2008 extended the period of nomination up to the 27th August 2008 due to Orissa Bandh Call given by Vishwa Hindu Parishad on the 25th August 2008;

And, whereas, it has been brought to the notice of the Commission that the law and order situation in Kandhamal district is not conducive for filing of the nomination and the Additional District Magistrate, Kandhamal has requested for extension of time for filing nomination.

Now, therefore, in exercise of powers conferred by Article 243-ZA of Constitution of India, Section 11-A of Orissa Municipal Act, 1950 and Rule, 23(1) and 79 of Orissa Municipal (Delimitation of Wards, Reservation of Seats & Conduct of Election) Rules, 1994, in partial modification to previous Notifications, the State Election Commission do hereby appoint the following dates & time with respect to the Municipal Election to Phulbani Municipality and G. Udayagiri N.A.C. of Kandhamal district :—
