### NOTIFICATION

The 12th September 2008

**S.R.O. No.453/2008**— Whereas the draft of certain rules further to amend the Orissa Municipal Corporation (Division of City into Wards, Reservation of Seats and Conduct of Election) Rules, 2003, was published as required by sub-section (1) of section 656 of the Orissa Municipal Corporation Act, 2003, (Orissa Act No.11 of 2003) in the extraordinary issue No.517, dated the 28th February, 2008 of the *Orissa Gazette* under the notification of the Government of Orissa in the Housing & Urban Development Department No.6823-Legis-III-OMC-1/2007-HUD., dated the 26th February, 2008 as S.R.O No.118/2008, inviting objections and suggestions from all persons likely to be affected thereby till the expiry of the period of thirty days from the date of publication of the said notification in the *Orissa Gazette*;

And whereas, objections and suggestions received during the specified period in respect of the said draft have been duly considered by the State Government;

Now, therefore, in exercise of the powers conferred by section 16 and 79 of the said Act, the state Government do hereby make the following rules further to amend the Orissa Municipal Corporation (Division of City into Wards, Reservation of Seats and Conduct of Election) Rules, 2003, namely:—

1. (1) These rules may be called the Orissa Municipal Corporation (Division of City into Wards, Reservation of Seats and Conduct of Election) Amendment Rules, 2008.

(2) They shall come into force on the date of their publication in the *Orissa Gazette*.

2. In the Orissa Municipal Corporation (Division of City into Wards, Reservation of Seats and Conduct of Election) Rules, 2003 (hereinafter referred to as the said rules), in rule 22, for sub-rule (1) excluding items (a) to (d), the following sub-rule shall be substituted, namely:—

“(1) As soon as notification by the State Government under section 64 is published, the Election Commission shall, by notification in the official gazette, appoint.”

3. In the said rules, in rule 29, for sub rule (1), the following sub-rule shall be substituted, namely:—

“(1)(a) On completion of scrutiny of nomination the Election Officer shall prepare a list of validly nominated candidates in Form No. XIV for each ward, arrange them in alphabetical order in Oriya and publish it on the notice board of his office.

(b) After expiry of the period within which candidature may be withdrawn under sub-rule (1) of rule 30, the Election Officer shall in Oriya prepare a final list of contesting candidates for each ward in Form XIVA of persons whose nominations have not been rejected and who have not withdrawn their candidature and publish it on the notice board of his office not later than two days after the expiry of the period within which candidature may be withdrawn and at least four days before the date fixed for the polling”.

4. In the said rules, rule 32 shall be omitted.

5. In the said rules, after the Form XIV, the following Form shall be inserted namely:—

6. In the said rules, in Form XIV, in right top corner below the words “Ward No.....” appearing in first line, the words “Reservation Status” shall be added.

7. In the said rules, in Form No. XXIV for part-II, the following part shall be substituted, namely:—
